

The Cannon Falls City Council met in a regular session on Tuesday, July 15, 2025, in the City Council Chambers. Present were Council Members Ryan Jeppesen, Chad Johnson, Diane Johnson, Laura Kronenberger, Chris Nobach, and Lisa Zimmerman; Mayor Matt Montgomery was absent. Also present were Jon Radermacher, City Administrator; Sara Peer, City Clerk; Jed Petersen, Public Works Director; Laura Qualey, Community & Business Development Specialist; and Jeffrey McCormick, Police Chief.

Call to Order	Mayor Pro Tem Kronenberger called the City Council meeting to order at 6:30 p.m.
Roll Call	Roll call was conducted. Council Members Jeppesen, C. Johnson, D. Johnson, Kronenberger, Nobach, and Zimmerman were in attendance.
Pledge of Allegiance	Mayor Pro Tem Kronenberger led the recitation of the Pledge of Allegiance.
Approval of Agenda	A motion was made by Council Member Jeppesen, seconded by Council Member D. Johnson and unanimously carried, to approve the Agenda as presented.
Public Input	There was no public input.

Council Business:	There was no other Council business.
Reports: Council Committees, Commissions, Nonprofit Organizations	Community & Business Development Specialist Qualey reported that a special Public Works & Park Board meeting has been scheduled on July 24. She stated that a proposed MnDOT Active Transportation Program demonstration project will be discussed, with the plans and a recommendation to be forwarded for Council review in August.
Staff	Public Works Director Petersen reviewed upcoming mill-and-overlay projects. He stated that a proposed new truck will be discussed with

the Public Works & Park Board during the July 24 special meeting and then with the City Council in August.

Police Chief McCormick reported that, aside from a few heat-related medical emergencies, the Cannon Valley Fair ran smoothly.

City Administrator Radermacher reported that a joint work session with the City Council and the Planning Commission has been scheduled on July 21 for discussion of a proposed zoning text amendment. He stated that a meeting has been scheduled with Randolph Township representatives to discuss an orderly annexation process.

Council Member D. Johnson discussed an earlier meeting with City staff.

Council Member C. Johnson suggested scheduling a Cable Commission meeting for discussion of local programming, opportunities for volunteer assistance from the community, and equipment.

Council Member Jeppesen requested updates regarding McDonald's and Kwik Trip.


Regarding Kwik Trip, City Administrator Radermacher stated that an updated traffic study has been completed and forwarded to MnDOT, with a follow-up meeting to be scheduled for further discussion.

Regarding McDonald's, City Administrator Radermacher stated his understanding that McDonald's intends to rebuild on the current site.
